*In the case of inclement weather, call the rec office at 861-1045, one hour before game time for cancellation notice.

*Food and drink (other than water) are not permitted in the gym.

*NFHS rules will be followed except for exceptions listed below.

*Each game will consist of two, 20 minute halves with the clock stopping for timeouts, injuries and during the last two minutes of each half or during an overtime period.

*Each team will be granted (2) full timeouts per half. Timeouts do not carryover.

*If needed, overtime will consist of 3 minutes (stop clock) and each team will be granted one timeout.

*Any player who receives two technical fouls in one game will automatically be ejected from that game and suspended for the next game. Any player who engages in a fight (referee discretion) will be ejected from the game and will receive an additional two game suspension. Based on the severity of the infraction, a player may be expelled from the league.

*Only players officially registered through the Dennis Township Recreation Department are permitted to participate. The use of a non registered player is strictly prohibited and will result in the offending team receiving an automatic forfeit.
