Mayor Murphy opened the meeting in compliance with the Open Public Meetings Act requirements.

Mayor Murphy presided with Committeemembers: DiCicco, O'Connor and Crippen present, Committeewoman Blessing was absent.

The Committee discussed the following:

DEPARTMENTAL REPORTS AND PROJECT UPDATES:

Administration & Finance:

The Committee discussed the Vision Service Plan renewal and indicated that it was ok.

Public Works & Engineering:

The Engineer discussed the status of the drainage issue on Beaver Dam Road and County Route 657. The Engineer commented on his meeting with the property owner, Mr. Dempsey, and his Engineer Mr. Reed. The Township Engineer requested authorization from the Committee to meet with the County Engineer, Dale Foster, to discuss this issue and they indicated ok.

The Engineer commented on the status of the ADA Improvements to Chestnut Stree Park and indicated that the Bid documents had been forwarded to TRIAD Assoc. so that they can file the necessary paperwork with the DCA regarding the grant.

The Engineer commented on the Brewers Lane subdivision and the Planning Board requirement of sidewalks which have not been installed. The Committee advised the Engineer to send a letter to Mr. Brewer requesting a time-line for the completion of the sidewalks.

The Committee discussed the Hagen Road Project and asked the Engineer to look into their options.

Tax Offices:

The Committee discussed the request for a tax lien certificate assignment for Block 57, Lot 16, C0341. They decided against the assignment because everyone felt that people interested should participate in the Tax Sale.

Planning & Zoning:

The Mayor discussed forming an Advisory Board to review the Master Plan Re-Exam. the correspondence the Township received
