**6:30 P.M. (PREVAILING TIME) TWP. COMMITTEE WORKSESSION MEETING**

Mayor Murphy opened the meeting in compliance with the Open Public Meetings Act requirements.

**DEPARTMENTAL REPORTS AND PROJECT UPDATES:**

**Administration & Finance:**

The Committee indicated that in light of their being able to get the 2011 Budget to a 0 increase, that at this time they would not explore raising various fees.

The Committee discussed at length the Dennisville Historic Home Owners Association's survey regarding sidewalks with the Association President, Jack Connolly. Mr. Connolly shared his results from the survey. Comments and concerns as to liability issues were heard from resident Bob Grace. The Committee instructed the Clerk to send out a memo to Dennisville affected area residents advising them that a resolution supporting this venture would be on the May 17<sup>th</sup> agenda and if they have any concerns to attend said meeting.

**Public Works/Engineering:**

The Committee discussed the proposed Shared Services Agreement for Solid Waste Disposal and Recycling Services from the C.M.C.M.U.A. Resident Bill Burian commented on ways to save money with the trash and recycling pick-up. The Committee indicated that a resolution for the Shared Services Agreement should be placed on an up coming agenda.

The Committee discussed the speed limit on Sunny Lane. Committeeman Glembocki indicated that he has received some complaints. Township Engineer commented on regulations for reducing speed limits and Committeeman O'Connor indicated that he would inspect the street for current signage.
